#### **School Policy on Watches / Fitbits**

I would like to clarify with parents the school's policy on the wearing of watches and Fitbits. The children are welcome to come to school wearing such items, however the school feel it important to clarify that in the event of loss or breakages that we can not be held responsible. This week we have also considered the appropriateness of Apple watches or other such devices. The school are clear that such items are acceptable as long as they have no connectivity to the internet and messaging or telephone facilities (ie does not contain a Sim card). Once again it is important to stress that if parents choose to allow a child to wear such devices, responsibility for any loss or breakages will not be held by the school. I have also briefed staff, that if an individual becomes distracted from learning due to such devices that the child will then be asked to take them off and not be permitted to wear in future.
